<sup>4</sup> Local Governmental Agencies requesting an update that is intended for use by a contracted/appointed Engineer, must have that Engineer certify in writing, by the principle-in-charge, that the BRADD software will only be used for work of the Local Governmental Agency, and will not be used for consulting work. The written certification must be received before an update is issued.
